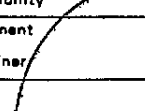

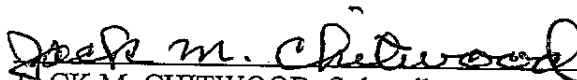
**ARTICLE IX - INDEMNIFICATION**
