#### ARTICLES OF INCORPORATION

ASTONAUE 14 AMILION undersigned subscribers to these Articles of The Incorporation, being natural persons competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

## ARTICLE I

## CORPORATE NAME

The name of this corporation is KRANTZ ESTATES, INC.

## ARTICLE II

## DURATION

The corporation shall have perpetual existence beginning with the date of the execution of the Articles.

## ARTICLE III

## PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

## ARTICLE IV

#### CAPITAL STOCK

The corporation is authorized to issue 7500 shares of \$1.00 par value common stock, which shall be designated "common shares". The stock of this corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and all regulations issued thereunder. Such actions as are necessary will be taken by the officers of this corporation to accomplish this compliance. This corporation is being capitalized and its stock is being issued to comply with the aforementioned section of the Internal Revenue Code.

#### ARTICLE V

## PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the corporation of the same kind, class, or series as that which they hold, shall the right to purchase their pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
