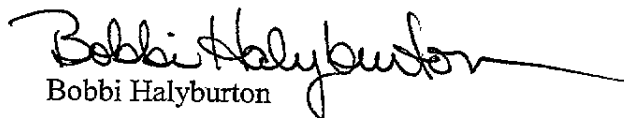

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is J.S. Investments of Northeast Florida, Inc.

ARTICLE II

The existence of the Corporation shall begin when these Articles of Incorporation are accepted for filing by the Secretary of State, Division of Corporations.

ARTICLE III

The street address of the principal office of the Corporation is 3400 U.S. 1 North, Suite 6, Bunnell, Florida 32110. The mailing address of the Corporation is P.O. Box 351082, Palm Coast, Florida 32135-1082.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is One Hundred (100), par value \$.01 per share, all of which shall be Common Shares. 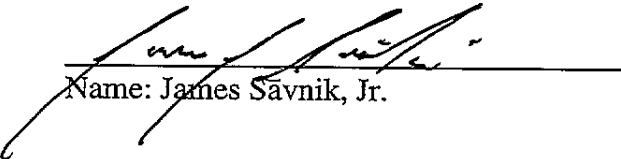
