ARTICLE ONE

The name of this corporation is **MIDWEST LAWN CARE OF LEE COUNTY, INC.** and the mailing address of the corporation shall be 14064 Shimmering Lake Court, Fort Myers, FL 33907.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

1. To engage in the business of lawn maintenance.
2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.






