ARTICLES OF INCORPORATION

ARTICLE - I

The name of this corporation is: LEGACY HOMES DESIGN & CONSTRUCTION, INC.

ARTICLE - II

The purpose of this corporation is to design and build residential homes and commercial buildings, and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock

ARTICLE IV - PRE EMPTIVE RIGHTS
