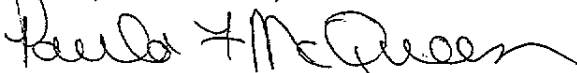

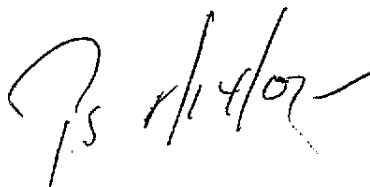

ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is AIRPARK DEVELOPERS, INC. The principal office and mailing address of this corporation is as follows: 1625 W. Marion Avenue, Suite 6, Punta Gorda, Florida 33950.
