<u>ARTICLE I</u>

The name of this Corporation shall be: EJR HEALTH SERVICES, INC.

ARTICLE II

The principal office of this Corporation shall be located in the City of Key Biscayne, County of Miami-Dade, State of Florida, and the Post Office address of said principal office of the Corporation shall be 607 Ocean Drive, Apt 6K, Key Biscayne, Florida 33149.
