**ARTICLE VII**

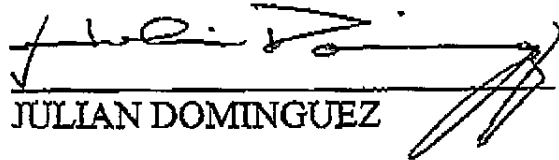
