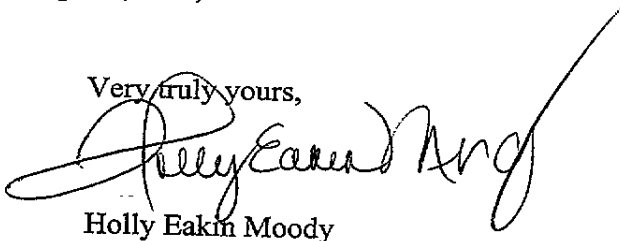

ARTICLES OF INCORPORATION
OF
OLSON HOLDING CORP.

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be Olson Holding Corp.

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at:

3331 E. Oakland Park Boulevard
Ft. Lauderdale, Florida 33308

ARTICLE III

DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV

PURPOSE

This corporation is organized for the following purposes:

- a) a scuba school and dive shop.
- b) The transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE V

CAPITAL STOCK

The authorized capital stock of this corporation shall be one hundred (100) shares of Common Stock at One (\$1.00) Dollar par value.

ARTICLE VI

RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK

Since this corporation shall issue only one class of stock, to wit: Common Stock, there shall be no preferences or limitations in respect to the individual shareholders of such stock.

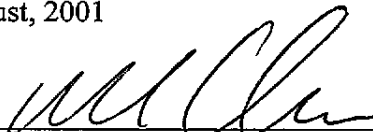

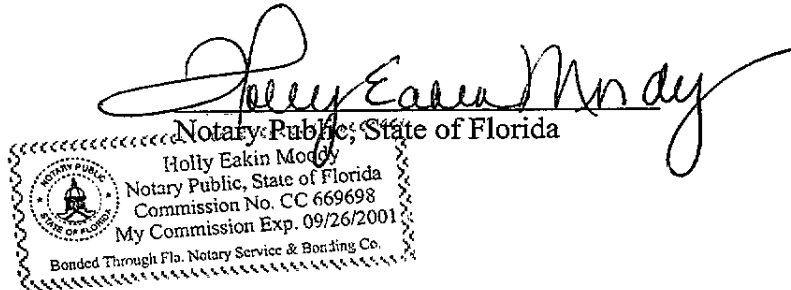
