**ARTICLES OF INCORPORATION  
OF  
PRECISION FITNESS CENTERS, INC.**

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I**

The name of the Corporation shall be **Precision Fitness Centers, Inc.**

**ARTICLE II**

The principle office of this Corporation shall be located in the City of Ft. Lauderdale, Broward County, Florida and the street address of said principle office shall be, 5555 Anglers Avenue, Suite #23, Ft. Lauderdale, Florida 33312.

**ARTICLE III**

This Corporation is organized for the following purposes:

1. To engage in the operation of a health and fitness center.
2. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

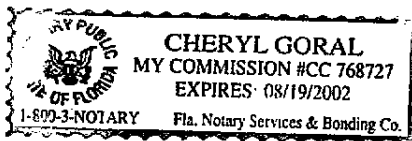
