

ARTICLES OF AMENDMENT
OF
INTEGRATED PRESS & PRINTING, INC.

I, the undersigned sole Officer, Director and Stockholder of INTEGRATED PRESS & PRINTING, INC., hereby file these Articles of Amendment for the purposes herein expressed:

1. ARTICLE II, Subsection 1, of the Articles of Incorporation of INTEGRATED PRESS & PRINTING, INC., which was filed on August 10, 2001 under Charter Number P01000080204 is hereby amended to read as follows:

“The general character, purpose, and nature of business to be transacted by this corporation is as follows:

1. To engage in the business of printing, manufacturing, selling and distributing all types of signs and signage; to engage in the business of printers, lithographers, stereotypers, electrotypers, photographic printers, photolithographers, photoengravers, diesinkers, blank book manufacturers, book binders, and stationers, and the printing of books, pamphlets, periodicals, newspapers, posters, circulars, envelopes, bill and letterheads, cards tags, labels, commercial, financial, and law blanks and forms of every description, railroad and other tickets, and any and all kinds of documents, instruments, and other printed matter; to conduct the aforesaid business in all of its branches; and to do such other things as are incidental, proper, or necessary in the operation of the business and in the carrying out of any or all of its purposes.”

The foregoing amendment was adopted by the sole Director and Stockholder of this corporation on the 14th day of January, 2003 pursuant to written statement manifesting the intention of all of the Directors and Stockholders that this Amendment to the Articles of Incorporation be adopted.
