ARTICLE I

NAME

The name of the Corporation is RTL Lawn Service, Inc. The principal office address and the mailing address of said Corporation is 9803 Creekfront Road #1007 Jacksonville, Florida 32256.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE
