The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

<u> ARTICLE I - NAME</u> The name of this corporation is WSD - SONELY DECORATION, CORP. (hereinafter, "Corporation")

3. No shareholder of the Corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

#### ARTICLE IX POWER OF CORPORATION

#### ARTICLE X INDEMNIFICATION

#### ARTICLE XI DISSOLUTION

The corporation may be dissolved at any time on the affirmative vote or the holders of at least two thirds (2/3) of the outstanding shares of the corporation entitled to vote thereon. On dissolution the corporate property and assets shall, after payment of all debts of all debt of the corporation, be distributed to the shareholders pro-rate; each shareholder to participate in direct proportion to the number of shares held by him.
