

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation is FUTUREWORKS, INC.

**ARTICLE II
PURPOSE**

This corporation is organized for the purpose of providing educational consulting services as well as all other activities permitted under the laws of the State of Florida and the United States of America.

**ARTICLE III
CAPITAL STOCK**

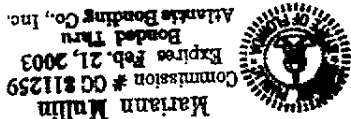


