The undersigned, acting as Incorporator of a corporation under the Florido General . Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is **AMERICAN PROPERTY**GROUP NO. II, INC.
