ARTICLE I

Name

The name of this professional corporation is:

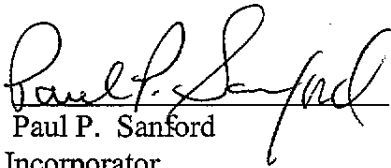

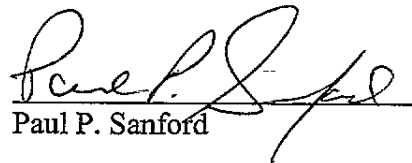
