ARTICLE I - NAME

The name of the Corporation is JASON'S TOOLS, INC.

ARTICLE II - EXISTENCE

This Corporation shall commence its existence on the date of the filing of these Articles and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - NATURE OF BUSINESS

The general purposes for which this Corporation is organized are:
