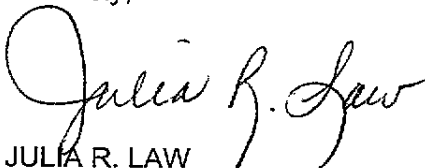

ARTICLES OF INCORPORATION

OF

FRESH DOUGH PIZZA CORP.

The undersigned subscribers to these Articles of Incorporation, natural person competent to contract, hereby set forth their intention to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is FRESH DOUGH PIZZA CORP.

ARTICLE II

This corporation shall exist perpetually.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE V

ARTICLE VIII

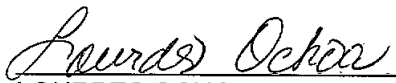

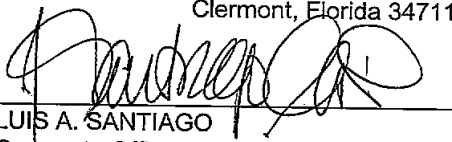

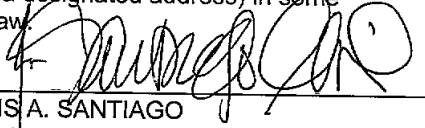
