ARTICLES OF INCORPORATION

CWB Technologies, Inc.

ARTICLE 1 - NAME

The Name of the corporation shall be:

### **ARTICLE 2 - DURATION**

This corporation shall exist in perpetuity.

# **ARTICLE 3 - PURPOSE**

General nature of the business and the object and purposes proposed to be transacted and carried on, are to do any and all of the things mentioned herein, as fully and to the same extent as natural personas might or wild viz: Engage in any business or activity permitted under the laws of the United States and the State of Florida, including but not limited to the following:

a) To take, acquire, buy, hold, own, maintain, work develop, sell, convey, lease, mortgage, exchange, improve and otherwise invest in and dispose of real estate and real property or any interest or rights therein without limit as to the amount; to do all things and engage in all activities necessary and proper or incidental to the business of investing in and developing real estate.
