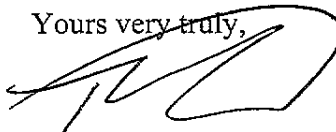

4. That these Articles of Dissolution are effective as of the date subscribed herein below.

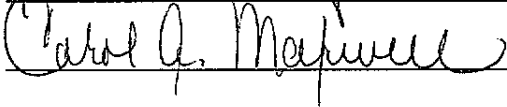

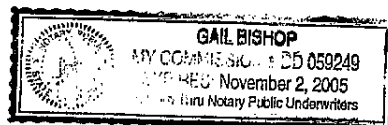
