# ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of the corporation is OLD PARR CORP.

#### ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpenual existence, commencing at the filing of these articles with the Department of State,

#### ARTICLE III. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV. CAPITAL STOCK

The aggregate number of shares of stock which the corporation shall have authority to issue is five hundred (500) shares of common stock at a par value of one dollar (\$1.00) per share.
