The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE – NAME**

The name of this corporation is RBL Enterprises of Palm Coast, Inc.

**ARTICLE TWO – PRINCIPAL OFFICE**

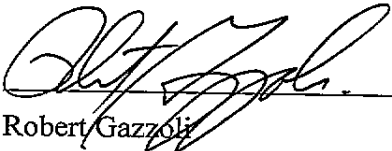

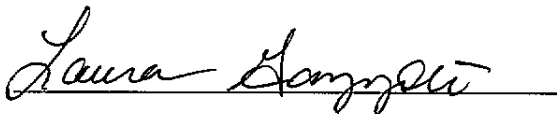
