## ARTICLES OF INCORPORATION ALL ART AND DECORATION BY CANO, INC.

WE, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the Laws of he State of Florida and, under the statute of the State of Florida providing for the formation, rights, privileges, immunities an liability of incorporating for profit it is:

#### **ARTICLE I**

The name of the corporation shall be ALL ART AND DECORATION BY CANO, INC.

#### ARTICLE II

The corporation shall engage in any activity or business permitted under the Laws of the State of Florida and the United States of America. ## ARTICLE XI

At all elections of Directors of this corporation each stockholder shall be entitled to as many votes as shall equal the number of votes which (except for those provisions as to cumulative voting) he would be entitled to cast for the election of the Director with respect to his shares of stock multiplied by the number of Directors to be elected and he may cast all votes for a single Director or may distribute them among the number to be voted for, or any one or more of them as he may see fit.

## ARTICLE XII

All rights of shareholders are subject to this reservation.
