ARTICLES OF INCORPORATION OF EQUITABLE SOLUTIONS, INC.

ARTICLE I: NAME

The name of this Corporation is:

Equitable Solutions, Inc.

ARTICLE II: DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III: PURPOSE

Equitable Solutions, Inc., is formed for the purpose of operating and transacting any and all lawful activity or business.

ARTICLE XIV: EXTRAORDINARY ACTION

The affirmative vote of fifty percent (50%) plus one of the Common Stock of Equitable Solutions, Inc., represented at a meeting at which a quorum is present, shall be required to amend these Articles so as to increase or decrease the authorized number of, or change the designations, preferences, qualifications, limitations, restrictions, or special or relative rights of any of the various class of shares; or to merge or consolidate Equitable Solutions, Inc., with or into any other Corporation or sell, lease, or convey all or substantially all of the assets of Equitable Solutions, Inc., or voluntarily to dissolve, liquidate, or wind up its affairs.
