I HOPE THIS LETTER WILL EXPLAIN WHY MY CORPORATION ANNUAL REPORT WAS NOT FILED ON TIME.

I RENT A SPACE IN THE USA FLEA MARKET AND AM ONE OF APPROXIMATELY 325 VENDORS AT THIS LOCATION. BEING NEW TO THE STATUS OF S-CORP I WAS UNAWARE OF REPORTING REQUIREMENTS BUT THAT IS NO EXCUSE.

THE PROBLEM I HAVE ENCOUNTERED HERE IS THAT ALL MAIL BEING DELIVERED TO THE FLEA MARKET ADDRESS GETS DELIVERED TO THE HEAD OFFICE AND THEY TAKE NO RESPONSIBILITY TO DELIVER THE MAIL TO ALL 325 VENDORS. THIS HAS BEEN A PROBLEM FOR A LONG TIME AND MANY TIMES MAIL WAS NEVER DELIVERED BY THE OFFICE PERSONAL.

ALL 325 TENANTS HAVE THE SAME ADDRESS WITH THE EXCEPTION OF UNIT #S. I HAVE TRIED UNSUCCESSFULLY TO GET MY OWN MAILBOX ASSIGNED BY THE POST OFFICE BUT THEY TELL ME THE AGREEMENT WITH THE ORIGINAL OWNERS STATES THAT ALL MAIL CAN ONLY BE DELIVERED TO THE MAIN OFFICE FOR ALL 325 TENANTS. THE CURRENT OWNERS TAKE NO RESPONSIBILITY TO PROMPTLY DELIVER ANY MAIL THAT COMES TO THEM.

THE TENANTS ALL GOT TOGETHER ANY SENT TO THE POST OFFICE CHANGE OF ADDRESS FORMS TO HAVE ANY MAIL COMING TO THE FLEA MARKET DIVERTED TO THEIR HOME. YOUR RENEWAL WAS ADDRESSED TO THE FLEA MARKET ADDRESS AND WAS NEVER FORWARDED TO ME.

I AM PROMPT IN PAYING MY OBLIGATIONS AS YOU CAN CHECK, I HAVE NEVER BEEN LATE ON MY PAYROLL TAX, SALES AND USE TAX AND MY TIRE TAX.

I AM SURE THE LANDLORD IS IN VIOLATION OF SOMETHING BECAUSE THE POST OFFICE SAID THEY ARE TO DELIVER THE MAIL TO EACH VENDOR.

I AM SURE YOU HAVE HEARD EVERY EXCUSE IN THE WORLD BUT MINE CAN BE VERIFIED BY ANY OF THE TENANTS OR THE POST OFFICE THAT THIS HAS BEEN A SERIOUS AND ONGOING PROBLEM
