

ARTICLES OF INCORPORATION
OF
SUNLIFE MATERNAL CHILD NETWORK, P.A.

The undersigned incorporator does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a professional corporation under the Florida Professional Service Corporation Act:

1. The name of the corporation is Sunlife Maternal Child Network, P.A. 2828 Croasdaile Dr., Durham, North Carolina 27705
2. The purpose for which the corporation is organized is to engage in the practice of providing medical services.
3. The corporation shall have the authority to issue One Hundred Thousand (100,000) shares of common stock with the par value of One Dollar (\$1.00) per share.
4. The address of the initial registered office of the corporation in the state of Florida is 1200 South Pine Island Road, Plantation, Florida the name of the initial registered agent at such address is CT Corporation System.
5. The name and address of the incorporator are Steven M. Scott, M.D., 2828 Croasdaile Drive, Durham, North Carolina 27705.
6. A director of the corporation shall not be personally liable for monetary damages for breach of any duty as director except and only to the extent applicable law restricts the effectiveness of this provision. Any repeal or modification of this article shall be prospective only and shall not diminish the rights or expand the personal liability of a director of the corporation with respect to any act or omission occurring prior to the time of such repeal or modification.
