In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ARNOW CONSULTING & TRAINING, INC.

ARTICLE II

The Corporation is being formed for the purpose of engaging in the business of software consulting & training, and for any other proper and lawful purpose as may be hereafter determined by the Board of Directors.

ARTICLE III

The existence of the Corporation shall begin on the date these Articles are filed in the office of the Florida Secretary of State.

ARTICLE IV

The street address of the principal office of the Corporation is 8707 Lake Calm Lane, Odessa, FL 33556.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 2,000, par value \$1 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

ARTICLE VII
