The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: ABE / DOS, INC.. The principal place of this corporation shall be: 1346 Main Street, Dunedin, Fl. 34698.

**ARTICLE II. NATURE OF BUSINESS**
