

ARTICLES OF INCORPORATION OF HING CHEN, INC.

THE UNDERSIGNED, acting as sole incorporator of HING CHEN, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME
