**ARTICLE I
CORPORATE NAME**

The name of this Corporation is AAKA RECREATIONAL PROPERTIES, INC. The principal office and mailing address of the corporation is 671 Seventh Street NW, Naples, Florida 34120.

**ARTICLE II
DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

**ARTICLE III
PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV
CAPITAL STOCK**

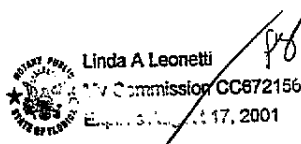

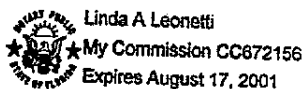
