

ARTICLES OF INCORPORATION
OF
ROSIE BRO FINANCIAL, INC.

ARTICLE 1. - NAME

The name of the corporation is ROSIE BRO FINANCIAL, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 679 Avenida Del Norte, Sarasota, FL 34242. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

The initial mailing address of the corporation shall be P.O. Box 48691, Sarasota, FL 34230-8691. The corporation may change its mailing address from time to time as permitted by law.

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 5. - SHARES

This corporation is authorized to issue 10,000 shares of voting common stock with a par value of \$1.00 per share.


