ARTICLE 1

The name of the corporation shall be CRIMINAL JUSTICE INTERNATIONAL ASSOCIATES, INC.

ARTICLE 2

The principal place of business will be 101 South Hall Lane, Maitland, Florida 32751; with a MAILING address of: Post Office Box 620605, Orlando, Florida 32862-0605.

ARTICLE 3

The purpose for which the corporation is organized is to engage in any lawful act or activity for which a corporation may be organized under the laws of the State of Florida.
