# ARTICLES OF INCORPORATION

OF

# BOCA BOB'S AIRPORT TRANSPORTATION SERVICE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to make contracts, does hereby form a corporation under the laws of the State of Florida.

## ARTICLE I

The name of the Corporation is Boca Bob's Airport Transportation Service, Inc.

#### ARTICLE II

This Corporation is formed for the purpose of engaging in any lawful activity or business permitted under the laws of the United States of America, the state of Florida, or any other state or country, more specifically to engage in the business of Transportation.

#### ARTICLE III

The aggregated number of shares which this Corporation shall have the authority to issue shall be 1,000,000 shares at \$.001 par value. The consideration to be paid for each share shall be fixed by this Corporation.

#### ARTICLE IV

The amount of capital with which this Corporation will begin business is Ten Thousand Dollars (\$10,000).

#### ARTICLE VI

No officers, directors or shareholders shall be personally liable for any debts of this Corporation.

#### ARTICLE VIII

The number of directors constituting the initial board of Directors of this Corporation is one (1). The name and street address of the initial director of this Corporation is:

The initial director may serve from time to time and may, by resolution, fix the number constituting the Board of Directors and may also name persons to fill vacancies on the Board of Directors created by and increase in the number of directors which occurs between annual meeting.
