ARTICLES OF INCORPORATION OF RONALD E. ROTH, P.A.

The undersigned for the purpose of forming a corporation under the Florida Personal Services Corporation Act, Chapter 621, Florida Statutes, do hereby adopt the following articles of incorporation.
