**ARTICLES OF AMENDMENT
OF
REFRIGERATED FLEET SERVICES, INC.
Charter No. PO1000082012
(Reflecting name change to
ITL Fleet Services, Inc.)**

Pursuant to Sections 607.1001, 607.1004, 607.1006, and 607.1009, Florida Business Corporation Act, the following provisions of the Articles of Incorporation of Refrigerated Fleet Services, Inc., a Florida corporation, filed in Tallahassee on August 20, 2001 be and they hereby are amended in the following particulars:

Article I be, and it hereby is, amended to read as follows:

"The name of this corporation is **ITL Fleet Services, Inc.**"

The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 9th day of March, 2006. The only voting group entitled to vote on the adoption of the Amendment consists of the holders of the corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group.
