The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be ORLANDO TRANSPORTATION GROUP, INC. The address of the principal office of this corporation shall be 2721 Spivey Lane, Orlando, FL 32837, and the mailing address of the corporation shall be the same.

ARTICLE II: NATURE OF BUSINESS AND PURPOSE
