ARTICLES OF INCORPORATION OF ROYAL BUSINESS, INCORPORATED

We, the undersigned incorporators, hereby associate ourselves together and make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles on Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME
