Article I shall be amended to read as follows:



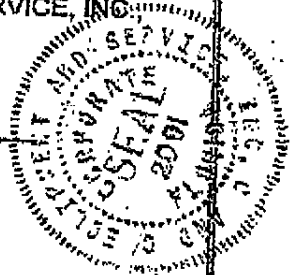
SECOND: The foregoing Amendment was approved by the Stockholders, on September 21, 2001.
