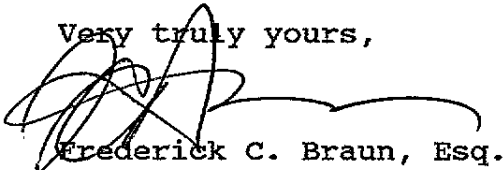

ARTICLES OF INCORPORATION OF  
CURRAN ELECTRIC, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be CURRAN ELECTRIC, INC.

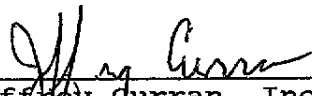

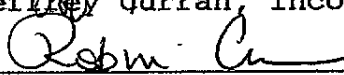

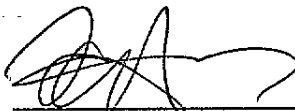
