ARTICLES OF INCORPORATION OF AUTO UNLOCK & KEYS, INC.

SECRETARY OF STATE FALLAHASSEE, FLORIDA

The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

AUTO UNLOCK & KEYS, INC.

and it shall be hereinafter referred to as the "corporation".

ARTICLE II

The time and date on which corporate existence of this corporation shall begin is 12:01 am (Eastern Standard Time) on August 15, 2001, and this corporation shall have continuous and perpetual existence thereafter.
