ARTICLES OF INCORPORATION OF

ARTICLE I - NAME Caribbean First Start Investments, Inc.

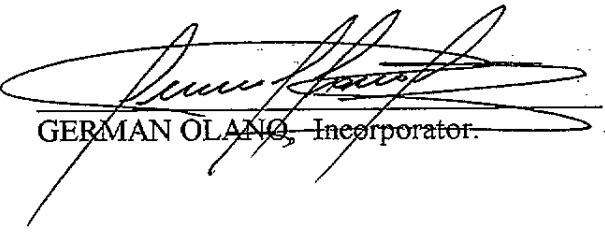

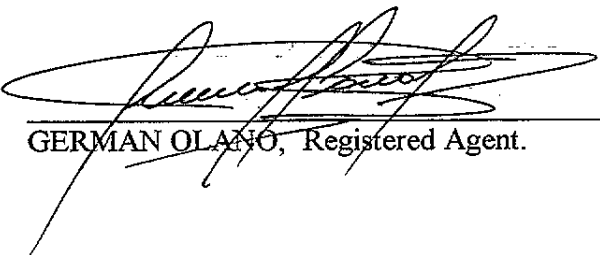
