ARTICLES OF INCORPORATION OF QUINCEY TRANSPORT, INC

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is QUINCEY TRANSPORT, INC.

ARTICLE II

The existence of the corporation shall begin on September 1, 2001. The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders as provide in these articles.
