## ARTICLES OF INCORPORATION OF QUINCEY TRANSPORT, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### ARTICLE I

The name of the corporation ("Corporation") is QUINCEY TRANSPORT, INC.

### ARTICLE II

The existence of the corporation shall begin on September 1, 2001. The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders as provide in these articles.

### ARTICLE III

The street address of the principal office of the Corporation is 7551 N. W. 95<sup>th</sup> Street, Chiefland, FL 32626. The initial registered agent for the Corporation at that address is VALERIE QUINCEY.

### ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one-hundred (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 75 shareholders. Stock will be issued and transferred only to (a) natural persons, (b) estates, or (c) a trust defined in IRC §1361(c)(2) (or its successor section). In addition, no stock shall be issued or transferred to a nonresident alien.

### ARTICLE V

The corporation is to be managed by its shareholders and not by a board of directors. The number of initial shareholders is one and the name and address of the initial shareholder is:

ARTICLE VII

The corporation shall indemnify its officers, employees, and agents to the fullest extent permitted by law.

ARTICLE VIII

The corporation may be dissolved at any time (a) by unanimous written consent of the shareholders; or (b) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares by the shareholder.
