Pursuant to Chapters 607 and 621 of the Florida Statutes, the undersigned Incorporator of Christopher M. Weiss, M.D., P.A., a Florida professional corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I  
NAME AND ADDRESS**

**ARTICLE II
