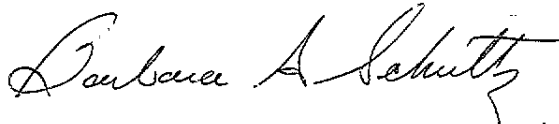

The undersigned hereby forms a Corporation under the following
Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be A-Z ONE STOP STATION,
INC. The address of this corporation is: 2295 Corporate

ARTICLE II

The purpose of the Corporation is to engage in any activity or

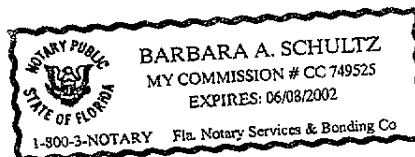
