
**ARTICLES OF DISSOLUTION

1. The name of the Corporation is: **Shoma Homes at Black Diamond, Inc.** The Document Number of the Corporation is P01000082593. The filing date of the Articles of Incorporation of the Corporation was August 21, 2001.
