**ARTICLES OF DISSOLUTION
OF
SHOMA HOMES AT GARDEN VALLEY, INC.,
A FLORIDA CORPORATION**

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, **Shoma Homes at Garden Valley**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: **Shoma Homes at Garden Valley, Inc.** The Document Number of the Corporation is **P01000082603**. The filing date of the Articles of Incorporation of the Corporation was **August 21, 2001**.
2. The dissolution of the Corporation was authorized by the sole Shareholder and the Directors of the Corporation by unanimous written consent dated as of **January 1, 2008**. The number of votes cast for dissolution was sufficient for approval.
3. The net assets of the Corporation remaining after the winding-up of the Corporation have been distributed to the shareholders of record.
4. In accordance with the Florida Business Corporation Act, the dissolution of the Corporation shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
