ARTICLES OF INCORPORATION

WHEREAS

The undersigned, desiring to form a Corporation for the purpose hereinafter stated under and Pursuant to Chapter 621 of the Florida Statutes do hereby declare as follows:

I. NAME

The name of the Corporation shall be B W Air Conditioning, Inc.

II. BUSINESS AND POWERS

SECTION A:
