ARTICLES OF INCORPORATION

ARTICLE I - Name and Address

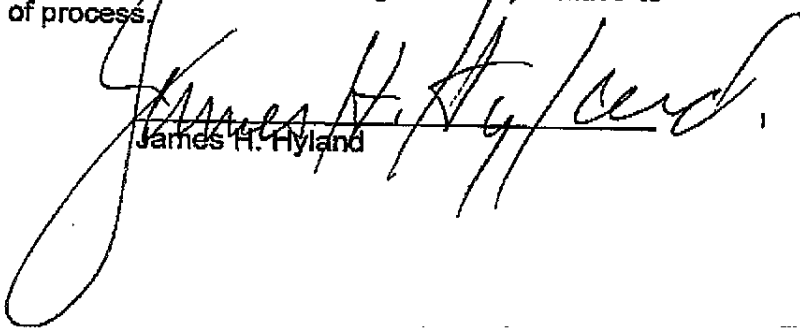
