

ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, _____
a natural person competent to contract, hereby forms a professional
service corporation for profit under the laws of the State of
Florida.

ARTICLE I

The name of this corporation shall be: _____

CHAR SIBIGA, P.A.

ARTICLE II

This corporation is organized for the sole and specific
purpose of rendering services as a broker or salesperson and
engaging in those activities permitted by Chapter 475, Florida
Statutes, and shall have as its shareholders only individuals who
themselves are duly licensed in the State of Florida under Chapter
475, Florida Statutes.

ARTICLE III

1. The maximum number of shares of capital stock that this
corporation is authorized to issue and have outstanding at any one
time is 7,500 shares of common stock having a nominal or par value
of One (\$1.00) Dollar per share.

2. All or any portion of the capital stock may be issued in payment for real or personal property, past services or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued as herein set forth and when so issued shall become and be fully paid and non-assessable, the same as though paid for in cash, and the directors shall be the sole judge of the value of the property, right or thing acquired in exchange for capital stock and their judgment of such value shall be conclusive.

3. Notwithstanding the foregoing, the corporation shall have the right to increase the number of authorized shares of capital stock either with or without nominal or par value, and to provide, in the event of such increase the designations, preferences and voting powers of such additional stock in an Amendment to its Articles of Incorporation.

ARTICLE IV

The amount of capital with which this corporation shall begin business is not less than Five Hundred (\$500.00) Dollars.

ARTICLE V

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE VI


